

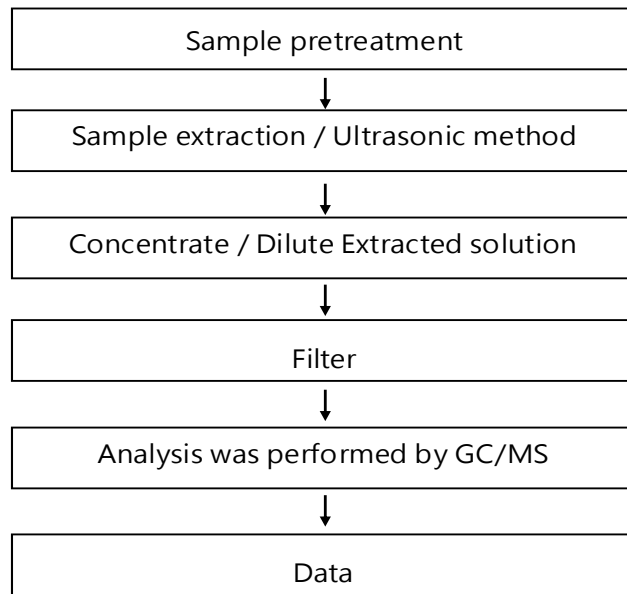

Analytical flow chart - Persistent, Bioaccumulative, Toxic (PBTs)



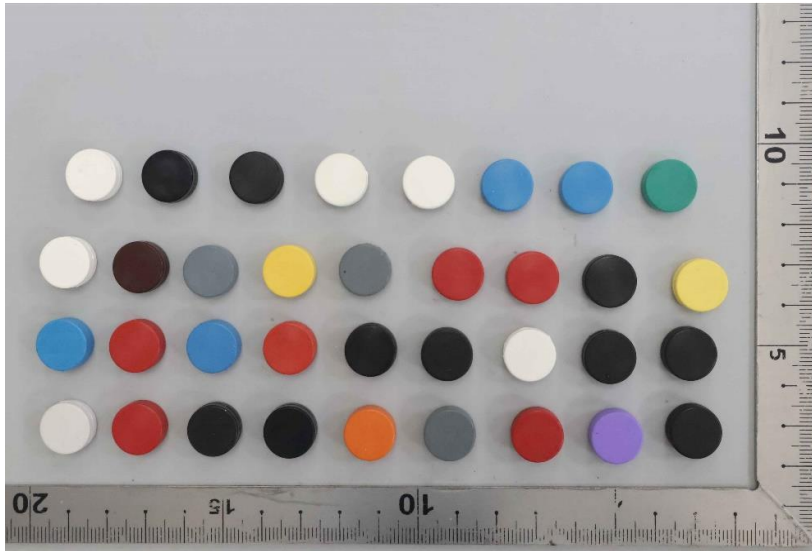
