

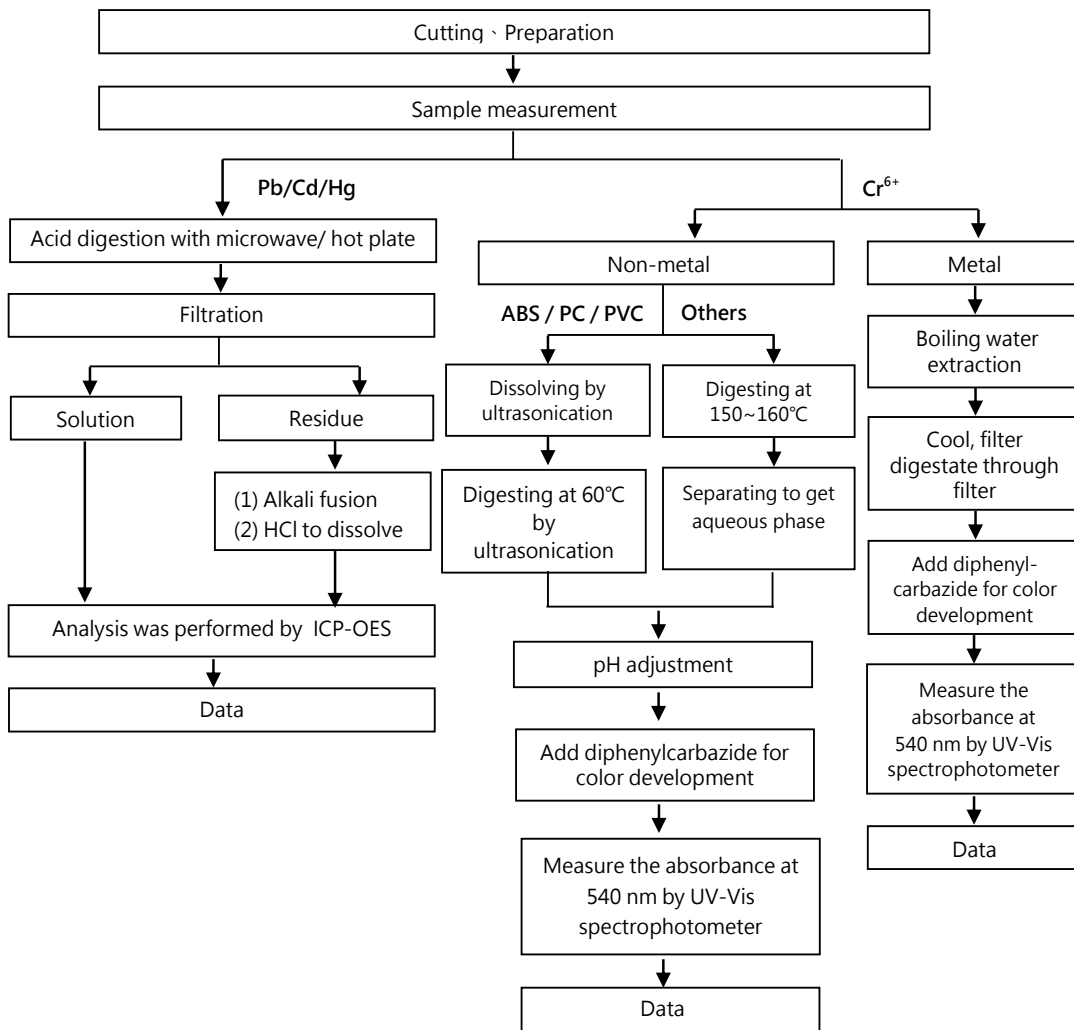

Analytical flow chart of heavy metal

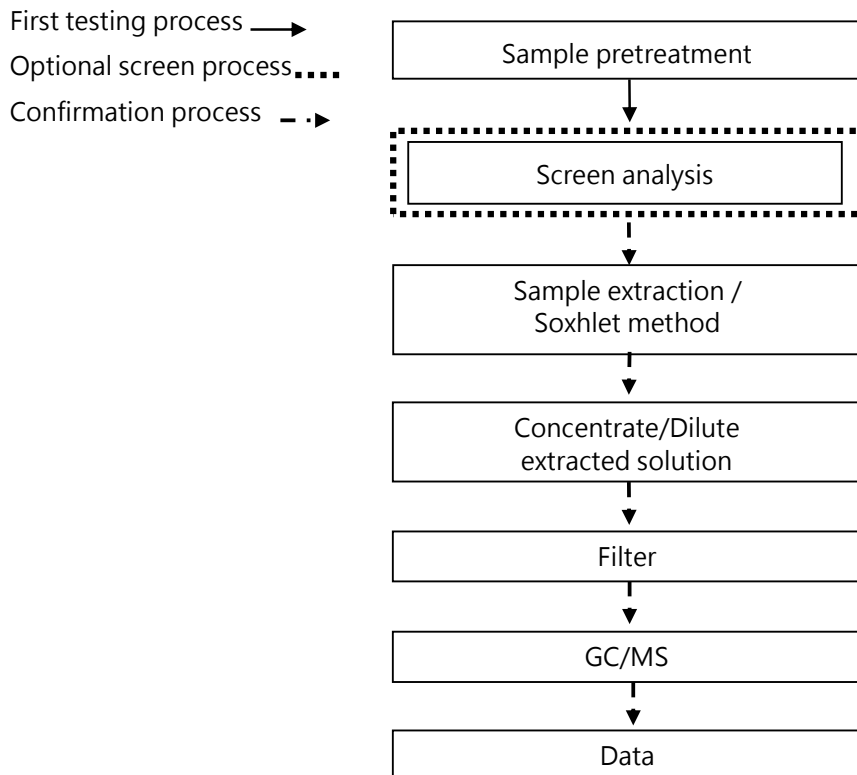
These samples were dissolved totally by pre-conditioning method according to below flow chart.

Analytical flow chart – PBBs / PBDEs



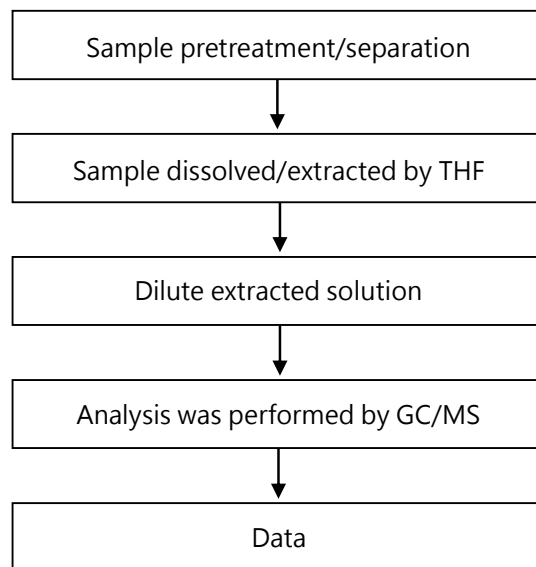

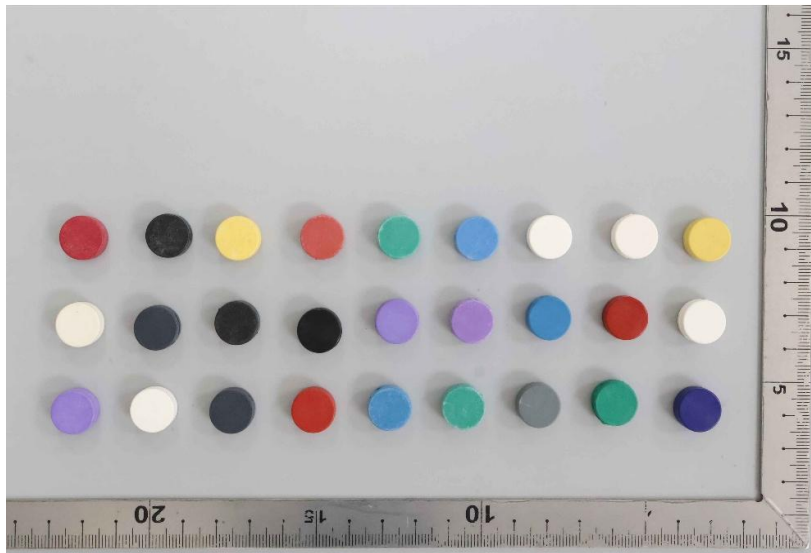
